## An Ordinance Amending Title 6:

#### Animals

WHEREAS Title 6, Chapter 6.4 of the City of Georgetown Code of Ordinances (hereinafter the "City Code") currently specifies various regulations for animals within the City of Georgetown; and

WHEREAS the City of Georgetown now desires to amend Title 6, Chapter 6.4 of the City Code regarding animals within the City; and

WHEREAS the City Council, after considerable thought and deliberation, has determined that it is in the best interest of the City of Georgetown to amend Title 6, Chapter 6.4 of the City code in the manner set forth hereinbelow.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

**Section 1.** The above recitals are hereby incorporated by reference herein as express findings of fact.

**Section 2**. This ordinance amends Title 6, Chapter 6.4. To the extent that the provisions of Title 6 or any portion thereof are inconsistent with the provisions of this ordinance, the same are hereby repealed.

**Section 3.** Section 6.4.080(E) is hereby amended to read as follows:

"E. Redemption of the animal may be made upon payment of the cost of impoundment and the pick up and redemption fees herein set forth, which fees shall be paid to the treasurer of the city as follows:

First Offense in a calendar year: \$150.00 Second Offense in a calendar year: \$175.00 Third and subsequent Offense in a calendar year: \$200.00"

Section 4. The City Clerk is empowered to publish this Ordinance in pamphlet form.

**Section 5**. This ordinance shall take effect immediately upon its adoption, execution and publication as provided by law, or as soon thereafter as allowed by law.

Section 6. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, by a majority of the members of the City Council of the City of Georgetown, Illinois, at a regular meeting of the Council on the 5 day of (Maynet), 2024
