City of Georgetown, Illinois Ordinance No. 2024-148

An Ordinance Amending Title 2: Administration and Personnel

WHEREAS Title 2, Chapter 2.04 of the City of Georgetown Code of Ordinances (hereinafter the "City Code") currently specifies the compensation to be received by Alderpersons for the City of Georgetown; and

WHEREAS the City of Georgetown now desires to amend Title 2, Chapter 2.04 of the City Code regarding the compensation for Alderpersons; and

WHEREAS the City Council, after considerable thought and deliberation, has determined that it is in the best interest of the City of Georgetown to amend Title 2, Chapter 2.04 of the City code in the manner set forth hereinbelow.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

Section 1. The above recitals are hereby incorporated by reference herein as express findings of fact.

Section 2. This ordinance amends Title 2, Chapter 2.04. To the extent that the provisions of Title 2 or any portion thereof are inconsistent with the provisions of this ordinance, the same are hereby repealed.

Section 3. Section 2.04.050(B) is hereby amended to read as follows:

"B. Aldermen shall be paid eighty-five dollars (\$85.00) for each regular meeting of the city council attended, eighty-five dollars (\$85.00) for each special meeting of the city council attended; and twenty dollars (\$20.00) for each committee meeting attended, in which they are a member."

Section 4. The City Clerk is empowered to publish this Ordinance in pamphlet form.

Section 5. This ordinance shall take effect in May 2025, immediately following the May 2025 Alderperson elections, following its adoption, execution and publication as provided by law, or as soon thereafter as allowed by law.
